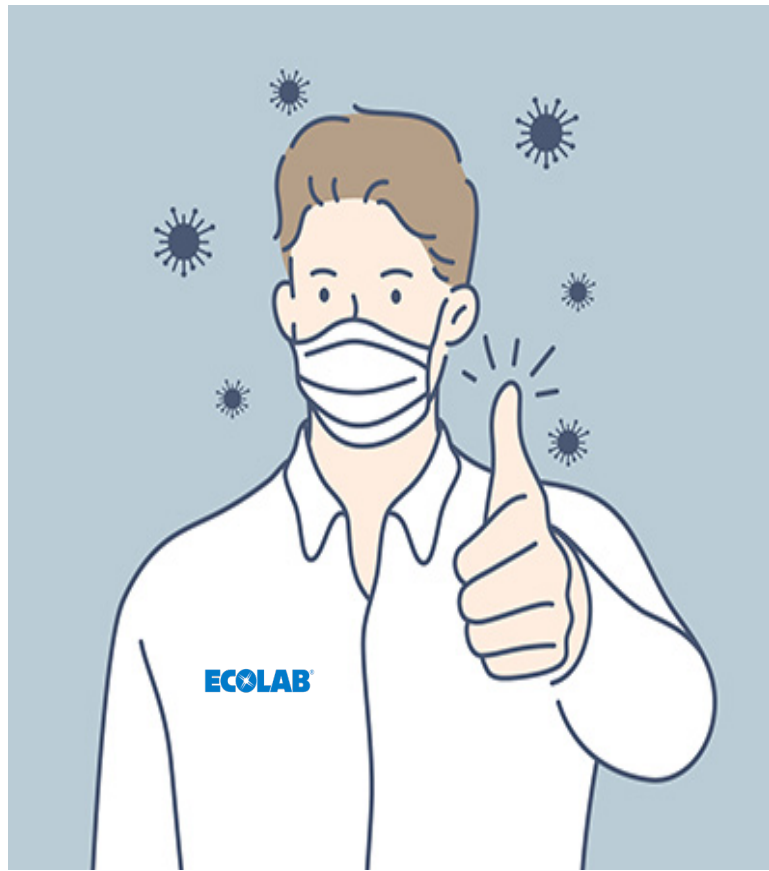




DEALER PROTECTION & SAFETY PROGRAM

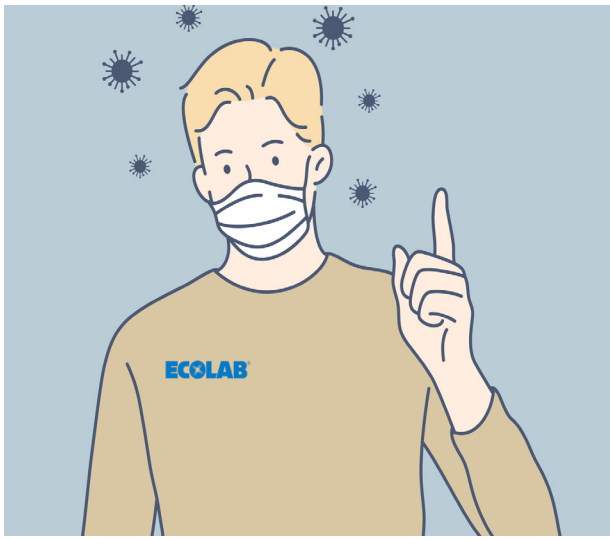
